Recommendations

1. The Board of Management approves the revised Calendar of Board of Management and Board Committee meetings for 2017-18, subject to any agreed changes.

1. Purpose of report

1.1 This is a revised draft schedule of Board of Management and Board Committee meetings for 2017-18, for approval by the Board of Management subject to any agreed changes.

2. Context

2.1 This draft reflects an adjustment to the dates of the first Learning and Teaching Committee in September 2017, which prompted an adjustment of the September meeting of the Finance and Physical Resources Committee. These adjustments have been made in consultation with the respective Committee Conveners and members.

2.2 This draft is version 2 of the draft as approved in June 2017, which was prepared with reference to the Calendar of GCRB Board meetings, previous CoGC Board Calendars, the required cycle of meetings, and the requirement for a number of approvals and submissions relating to the College's planning, reporting, and approvals cycle.

2.3 The Calendar has been endorsed by the Senior Management Team.

2.4 In summary the Calendar consists of:

- 1. Six meetings of the full Board of Management, including one all-day planning event (October 11th 2017), and one Evening/full-day residential event (February 14/15th 2018).
- 2. Three meetings of the Performance, Remuneration, and Nominations Committee (PRNC) between Board meetings (to facilitate delegated Board decisions/approvals). N.b. membership of PRNC is made up of Committee Conveners.
- 3. A regular cycle of Board Committee meetings preceding full Board meetings, with, where possible, a minimum two-week interval between the end of the Committee cycle and the full Board meeting, as per established practice.
- 4. Meeting days and times (usually 5pm) have been carried forward from 2016-17. However these are subject to review, to take account of Board members' circumstances and commitments.
- 5. At the request of GCRB, the full Board meetings precede those of GCRB by two weeks, to enable reportage as necessary.

3. Impact and implications

3.1 The pattern of meetings ensures a cycle of reportage from College Board Committees to the full Board, while meeting the Board's other obligations.
