1. Recommendations

The Committee is invited to note the paper, and discuss any matters as appropriate.

2. Purpose of paper

This paper includes a report on Health and Safety related matters from 1st April to 31st July 2017, as per the agreed H&S reporting format. These reports are set out under several key headings, and include a running total and comparative data over time relating to accidents and incidents within College premises. RIDDOR (reportable accidents / incidents) are included.

3. Context

The committee will note that the H&S reporting process requires a monthly H&S report to SMT which aims to provide an early focus on any H&S issues which may have arisen during the reporting period, usually the previous month. The idea is to ensure full SMT engagement with H&S issues and to allow a means which facilitates early exposure to risk and hence early intervention.

The reporting process also involves the production of a Quarterly H&S report to be presented to the H&S committee and subsequently to the FPRC. This report is produced from the H&S monthly reports already delivered to SMT covering April; May; June and July of 2017. These reports are set out under several key headings, and include a running total and comparative data over time relating to accidents and incidents within College premises. RIDDOR (reportable accidents / incidents) are included.

A report covering the 2 month period 1st January – 28st February 2017 was produced for the last F&PRC.

4. Impact and implications

The Health and Safety at Work etc. Act 1974 (HSAWA) sets out the general health and safety duties of the College, its board members, managers and employees, and places a duty on the College to ensure the health and safety of our employees and those that are affected by our activities, so far as is reasonably practicable. The Fire (Scotland) Act 2005 (FSA) places a similar duty on the College in respect of premises which we control.

If a health and safety offence is committed with the consent or connivance of, or is attributable to any neglect on the part of any manager or board member then that person (as well as the organisation) can be prosecuted under the HSAWA and FSA.

The Management of Health and Safety at Work Regulations 1999 and the Fire Safety (Scotland) Regulations 2006 set out more specific duties which support compliance with the HSAWA and the FSA (respectively), including assessing risks and making appropriate arrangements for the effective planning, organisation, control, review and monitoring of preventive and protective measures.

Reporting of Injuries, Diseases and Dangerous Occurrences Regulations


- A total of 42 accidents / incidents were reported in the current reporting period.
- A summary of all accidents / incidents for this period is at Appendix 1.
- Monthly and annual comparison figures and charts are presented below. The total number of accident / incidents reported for the reporting period for the year 2016 / 17 has increased by 20 compared to same period for last year 2015 / 16.
- 6 RIDDOR reportable incidents were notified to the HSE during this period 1 April

 31 July 2017- all involved students and all were taken straight to hospital from
 the College for treatment.
 - (1) Student landed badly when playing basketball, sustaining a possible sprain or fracture.
 - (2) Student received severe burns to right hand after removing a hot pan from the oven without using an oven cloth.
 - (3) Student who was taking part in a game injured left knee.
 - (4) Student leaned on a table top that was not fixed to the legs, the top gave way and the student fell to the floor with the corner of the table hitting the right shoulder.
 - (5) Student fell over during games, hurting right foot, unable to stand.
 - (6) Student was cutting plastic sheeting with scalpel when it slipped cutting left hand index finger

Patterns / Trends / Actions

- A total of 39 accidents / incidents took place at the City Campus and 3 at the Riverside Campus.
- There were 6 RIDDOR reportable incidents for this period compared with 2 for the same period last year.


- The number of staff involved in accidents / incidents for this period compared to the same period last year has risen from 6 for 2016 to 20 for 2017.
- There is an increase in the number of accidents / incidents for 16 / 17 compared to 15 / 16. Further accident / incident investigation may be required to determine the immediate; underlying and root causes of accidents / incidents which would allow the College to identify and implement corrective actions to prevent further occurrences.

 A total of 5 risk assessments were submitted on Connected in the current reporting period.

Fire

Fire (Scotland) Act Fire Safety (Scotland) Regulations

- An unwanted fire alarm signal occurred on 20/072017 as a result of dust contamination of an automatic fire detector leading to a full evacuation of the City Campus.
- A fire safety risk assessment was completed by a fire safety consultant for the City Campus in June 2017. An action plan has been developed to implement a number of identified remedial actions.
- A revised draft Fire Safety Risk Management Policy and Organisation and Arrangements has been completed.

Accident Claims Cases

 A letter of claim for a personal injury has been received by the College in relation to an accident to a student on 01/06/17. This incident was a RIDDOR reportable incident and was notified to the Health and Safety Executive (HSE) See appendix (32) for further details of the specific incident.

H&S Committee

The Safety Representatives and Safety Committees Regulations

- A meeting of the Health and Safety Committee took place on 23/06/13. Issues raised / discussed included a draft terms of reference and constitution for the Health and Safety Committee; fire safety management and fire safety risk assessments; environmental noise at work; dust at the City Campus associated with the Construction teaching areas; Joint Trade Union / Management Health and Safety Inspections, and further discussions on the proposal to have 2 H&S Sub Committees, 1 for Riverside and 1 for City. Several Actions emerged from the discussions which were:
- To forward the results of noise monitoring at the City Campus to all Committee members- complete.
- To forward a copy of the Fire Safety Risk Assessment for the Riverside Campus to all Committee members- complete.
- To arrange an environmental dust monitoring exercise at the City Campusongoing- Health and Safety Team liaising with an Occupational Hygiene Consultant on carrying out a monitoring exercise.
- Develop a programme of joint Trade Union / Management Health and Safety Inspections- ongoing discussions taking place between Trade Unions / Health and Safety Team.

Inspections

 No formal inspections carried out but various faults / issues observed have been reported or taken forward.
