Audit Committee

Our Audit Committee reported on the scope of internal audit and on improvements recommended by these audits. It has also considered risk management processes, accounting policies, anti-fraud policies, whistle-blowing processes, and the relevant Audit Scotland Reports. The Committee will continue to monitor and develop these activities, while also focusing on:

- Consolidating the regional accounts to give an even and complete view of regional finances and support the longer term strategic financial planning.
- Ensuring that GCRB fulfils the arrangements for assurance, accountability, and internal control that are required of a fully operational fundable body.

Performance and Resources Committee

Regionalisation has generated interesting and productive work for this committee. It will continue develop and strengthen our management of resources and performance and will address the following priorities:

- Development of regional strategies for Finance, Estates and ICT;

- Supporting increases in additional childcare provision;
- Delivering ESOL provision across the Community Planning Partnerships;
- Delivering and developing the Flexible Workforce Development Funding;
- Building a regional approach to student data management.

Curriculum Hub reviews

To support the development of curriculum planning for the 2018-19 ROA, the six Curriculum Hubs were asked to undertake evaluative reviews of current regional delivery. Reviews considered how well each curriculum meets regional economic and social needs, and the effectiveness of its learners' journeys. They identified strengths and opportunities to develop the work of each hub and ensure that the extent and nature of the college provision will:

- Match regional skills needs and support economic growth.
- Equip prospective and progressing student with the skills to build successful careers.
- Develop a truly inclusive college system.
- Continuously improve our effectiveness.

Intensifying outcomes through the Regional Outcome Agreement

A draft report on the 2018-19 Regional Outcome Agreement addresses the Scottish Government's intensification agenda and the SFC's consequent expectations in the areas of: widening access; articulation; attainment and retention; gender; Developing the Young Workforce (DYW); skills; innovation and; apprenticeships.

The draft report suggests that the GCRB focus on a subset of key targets which align to, and exemplify, regional strategic ambitions. These are:

- Increasing the participation of learners from deprived postcodes and other priority groups.
- Improving regional retention and attainment rates.
- Delivering more coherent Senior Phase pathways.
- Increasing opportunities for learners to progress to degree level.
- Increasing work-based learning.
- Delivering an inclusive and supportive student experience.
- Supporting every learner into a positive post course destination.

A regional STEM strategy

In October, the Scottish Government published a STEM Education and Training Strategy for Scotland. It envisages "... a Scotland where everyone is encouraged and supported to develop their STEM skills throughout their lives, enabling them to be inquiring, productive and innovative, in order to grow STEM literacy in society and drive inclusive economic growth."

The Glasgow Colleges' mission dovetails well with the national strategy and, for the first time, we can offer a regionally coherent response. A STEM Hub will strengthen regional collaboration. It will also support the development of our curriculum; of learning and vocational pathways; of gender inclusion and; of professional excellence. All this will contribute to our building Scotland's most inclusive, responsive and effective college system.
