- It is of particular note that CoGC's withdrawal rate in FTHE is the lowest in the sector.
- In comparison to the Scottish average the College sits 2.2% above it. CoGC sits at number 3 in Scotland and is 1.2% from the top of the sector.
- It is of note that Clyde College sit above Scottish average and Kelvin College are below it. Clyde FTHE PI has grown 1.6% and it matches CoGC.

- It is of note that Clyde and Kelvin sit below the Scottish average in FTFE.

- The College demonstrates sustained performance in PTHE over the last 4 years.
- In comparison to the Scottish average the College sits 4.3% above it. CoGC sits at number 2 in Scotland and is 3.8% from the top of the sector.
- Regionally all colleges have grown their PTHE CS, however there has been a marginal fall in CS in Scotland.
- It is of note that Clyde sits 3.7% above the Scottish average in PTHE and Kelvin sit 0.8% below.

- The College demonstrates sustained performance in FPTFE over the last 4 years.
- In comparison to the Scottish average the College sits 4.3% above it. CoGC sits at number 2 in Scotland and is 5.4% from the top of the sector.
- It is of note that Clyde sits 8.3% below the Scottish average in PTFE and Kelvin sit 4% above.
- Regionally PTFE CS has dipped, however Scotland PTFE CS has grown by 2.8%.

The table identifies that success for students from a SIMD 10, 20 and Care Experienced background is greater that the Scottish average. In each of these categories the College outperforms the Region, Clyde and Kelvin.
