Glasgow Region Update for Board Members

Partnership working to Develop the Young Workforce

Regional Leads presented to the Board on their progress in Developing the Young Workforce.

John Rafferty, Regional Lead for Developing the Young Workforce, presented his analysis of regional data on the scale, importance, levels, subject spread and success of the colleges' current activities with schools and their learners. This identified the need and potential to increase these activities. More research will inform our regional DYW strategy.

Audrey Miller, Regional Lead for Organisational Development, described the development of support for school and college staff to meet DYW's ambitions. This work includes a professional

dialogue session, half-day shadowing exchange opportunities, and a programme to equip secondary teachers to be able to inform learners about college admissions processes, student funding, etc.

Ambitious and attainable: 2018-19 Credit Targets and Funding Allocation

The Board noted that the SFC final credit targets and funding allocations remain broadly as agreed at our meeting of 26 March and included in our Regional Outcome Agreement 2018-19.

Still to be agreed with the SFC are the final targets for childcare training. These have increased significantly to meet the Scottish Government's commitment to double the free childcare entitlement by 2020.

The funding announcement provides £6.4m to meet the costs of National Bargaining in the Glasgow Region. It also provides £6.2m of capital funding to address 'very high priority' estates maintenance issues.

Improving our learners' journeys

In May, the Scottish Government published the final report of the 15-24 Learner Journey Review of education provision for all 16-24-year olds. This seeks to ensure that a national learning system enables efficient and effective learning journeys at every stage through:

- informed decision-making by the learner;
- the quality, value and reach of provision on offer to learners;
- straightforward, more efficient connections between parts of the system, including recognition of prior learning;
- equality of access to these opportunities, including suitable learner funding; and
- embedded partnership working with businesses and their representatives.

One of the report's conclusions was that the Scottish Government should support multi-college regions in developing coordinated application processes.

Intensifying retention and attainment

The Glasgow College Region is taking a progressive collaborative approach to intensifying our outcomes for learners. The Board agreed a proposed Regional Retention and Attainment group to look at our successful practices, ways to improve retention, and opportunities for regional collaboration. This work will inform a regional action plan to complement individual colleges' plans and support the ambitions of our ROA; improving retention and attainment throughout the region.
