1. Recommendations

The Learning and Teaching Committee is asked to discuss the content of this paper on the progress of the four Industry Academies within the Business and Management area to date, in the first few months, after the 2018 leadership reorganisation.

2. Purpose of report

The purpose of this report is to provide the Learning and Teaching Committee with an update on Industry Academy activity within the Business and Management area of the Faculty of Education & Humanities, highlighting the way in which the team is responding to opportunities and adding value to the curriculum through links to employment. A brief update on the latest meeting of the Regional Business Skills Hub will also be provided.

3. Context

Following the leadership re-organisation in late 2018, an Associate Dean for Business and Management was appointed with responsibility for four curricular areas, currently known as - Business 1, Business 2, Business Technologies and Legal Services, Newly appointed Curriculum Heads in Business & Management have now been challenged to oversee the development of high quality units and courses which meet employer demands and fully incorporate City Learning 4.0. There is a clear expectation that learning and teaching will have an employability focus and that staff will develop successful and sustainable partnerships with industry to ensure that students develop the skills and gain the knowledge to thrive, in what is now, an ever-changing and competitive global employability landscape. To this end, the Business and Management curriculum at City of Glasgow College will be characterised by guest lectures and masterclasses delivered by industry experts, field trips which bring learning to life, collaboration with business leaders, engagement with professional bodies, development of vocational pathways and important added-value experiences such as work experience, job shadowing, coaching, mentorship, internships and exciting employment opportunities.
